Description

DIRECTLY FROM THE OWNER - Attractive offices on the first floor in building 4 of the Inter Access Park in Groot Bijgaarden. These 806m² offices comprise the entire first floor and are modular (318m²/390m²/488m²/806m²) and equipped with air conditioning, raised floor, cable ducts, suspended ceiling, private sanitary facilities, kitchinette and carpet.

Outdoor (800 ℓ /p/y) and indoor parking (1,100 ℓ /p/y) as well as archives are available.

EPB (class) of the units on the left : (X) undefined – 296 kWhprim/m²/year. EPB (class) of the units on the right : (X) undefined – 237 kWhprim/m²/year.

A study is currently ongoing for the upcoming installation of solar panels.

The Inter Access Park is easily accessible both by car (Groot Bijgaarden exit near the intersection of the Brussels R0 ring and the E40 motorway), and by public transport (bus (MIVB: 83), tram (MIVB: 82) and train (NMBS station Sint-Agatha-Berchem) are all just 200 meters away).

There are several restaurants, sandwich shops and shops in the immediate area, as well as the Basilix shopping center.
